III. Approval of Agenda

IV. Approval of Regular Board Meeting Minutes 8/4/2020

A <u>motion</u> to approve the August 4, 2020, Regular Board meeting minutes as presented, was made by Linnette Davidson, seconded by Meredith Morneau. The motion passed unanimously.

V. <u>Information, Discussion and/or Action</u>

A. Finance Committee Report

Christine Lokken presented the July 2020 financial dashboard report.

B. Financials

A <u>motion</u> to accept the financial report for the month of July was provided by the Finance Committee, seconded by Kenny Porter. The motion passed unanimously.

C. Accounts Payable

A <u>motion</u> to ratify the accounts payable for the month of July was made by the Finance Committee, seconded by Teresa Kittridge. The motion passed unanimously.

D. 2021 Proposed Tax Levy

Dan Heinecke presented projections for 2021.

The certificate of proposed tax levy is due to Itasca County on or before September 30, 2020. The final levy is due on or before December 28, 2020. The final tax levy may exceed, be less than or equal to the proposed tax levy.

The Finance Committee made a <u>motion</u> to set the 2021 proposed tax levy at \$700,000, the same amount established last year, seconded by Teresa Kittridge. The motion passed unanimously.

E. CEO Report

Aaron Saude reviewed two trade confirmations from Edward Jones. The advance payment payback is on hold.

Adult Day Stay will remain closed. Aaron will reevaluate opening the program in 6 months.

Nursing homes are mandated to test employees based on the positive rate of the county. Bigfork Valley is currently required to test nursing home employees once a month.

The fitness center is currently open to employees. The dietary department is slowly opening.

Aaron will review the revenue cycle audit results with CliftonLarsonAllen today.

Aaron and Christine are evaluating options to refinance bonds. The option to refinance becomes available at the end of the year.

Aaron has an in-person meeting tomorrow with other local independent hospital CEOs to discuss how they can collaborate.

A local podiatrist is interested in doing some surgical procedures at Bigfork Valley.
