V. <u>Information, Discussion and/or Action</u>

A. <u>Finance Committee Report</u>

The Finance Committee reviewed the financials on Tuesday, November 24.

Darla Anderson presented the October 2020 financial dashboard report.

B. Financials

A <u>motion</u> to accept the financial report for the month of October was provided by the Finance Committee, seconded by Teresa Kittridge. The motion passed unanimously.

C. Accounts Payable

A <u>motion</u> to ratify the accounts payable for the month of October was made by the Finance Committee, seconded by Teresa Kittridge. The motion passed unanimously.

D. 2021 Final Budget

G. GRACF Endowment Distribution

A <u>motion</u> to withdraw \$21,144.00, the full amount available for distribution, was made by Kenny Porter, seconded by Marie Lovdahl. The motion passed unanimously. The funds will be earmarked for capital.

H. Attorney General Agreement/Policy Review

I. CEO Report

Aaron Saude reported that the opportunity to refinance bonds comes available in December. The COVID-19 Short Term Emergency/Health Care Response Funding Survey was submitted to the Minnesota Department of Health for potential additional COVID-19 funds. Price transparency will be required January 1. The nursing home census is low. The Villa has three open apartments. The Balsam Clinic is closed.
